

## **80th ANNUAL MEMBERSHIP MEETING**

September 16, 2020

### **Minutes**

Having determined that a quorum was present, Kim Freed, Chair of the Board of Directors, called the 80th Annual Meeting of the membership to order at Gain Federal Credit Union at 6:02 p.m. on Wednesday, September 16, 2020. This meeting was conducted both in person, with 18 members present, and virtually via Zoom due to the COVID19 Pandemic.
